NATURE OF WORK: There are four (4) categories of work accepted:

1. Portraits/Figures of People
2. People with their Pets
3. Still lifes (figure or portrait in work not necessary)
4. Landscapes (figure or portrait in work not necessary)

Subject matter of all artwork exhibited in the Galleries of Quiet Waters must be appropriate for the *family nature of the Park*.

Open to All Current Members of the MSPP, General and Accredited

FEES

\$15 for up to 3 works

DATES

Submission Deadline: April 26, 2018

Notification of Acceptance: First Week of May by email

Drop Off: Tuesday, May 22, 9:00-10:30am (THIS TIME IS FIRM DUE TO HANGING TIME FRAME)

Exhibit Opens: May 23, 2018

Opening Reception: June 3, 2:00-4:00pm

Exhibit Closes: July 8, 2018

Artwork Pick Up: July 9, 9:00-4:00pm

MEDIUM

2D and 3D work is accepted, including but not limited to drawings, paintings and sculpture

SIZE & QUANTITY

- 2D artwork, max size 60" in any direction including outside edges of frame
- 3D artwork must fit on 15" diameter pedestal

PUBLICITY

MSPP reserves the right to use any image included in the exhibit for promotional purposes.

SUBMISSION FORMAT (Deadline: April 26, 2018)

- 1. Email your images to *info.at.mspp@gmail.com* with “QUIET WATERS PARK” in the subject line. List images in PRIORITY ORDER, 1 being your preference.**
- 2. Submit 1 jpeg image per work entered; file size: 2-3 megabytes**

- 4. Include in the body of your email:

GUIDELINES

- Entering this exhibition shall constitute understanding and agreement on the part of the artist with the conditions stated.**
- Drawings, paintings, original prints on paper (not reproduced artwork, i.e. giclée) and sculpture completed within the last 3 years will be accepted
- Nudes will not be accepted due to the family nature of the park.
- All work must be created and conceived by the artist, no work created in classroom setting will be accepted. No photography, computer generated art, art done in a class, workshop or under supervision is eligible. All other media is accepted and encouraged, both 2D and 3D. Sculpture entries may include up to 3 views of the same piece.
- Works previously exhibited in a MSPP show are ineligible.
- Only digital entries will be accepted
- Images should only be of the artwork, DO NOT include matting, frame, etc in the image

COMMISSION

- Artist will receive 80% of sales price for any artwork sold. Friends of Quiet Waters Park retains 20%.
- All work must have sale price indicated, Not for Sale is acceptable. POR (Price on Request) *NOT* acceptable.

FRAMING

- ALL WORK MUST BE PROPERLY FRAMED AND WIRED, ready to hang. MSPP reserves the right to refuse unacceptable frames, i.e., wood strips, lack of wires. 2-D work *must have a frame* with a secure wire or hooks on the back to accommodate the gallery's hanging system. *No clip-on or poster frames. No gallery wrapped or painted canvas sides. Entries mounted behind glass without frames will not be accepted. Work not in compliance may be turned away and not allowed into exhibit.*

LIABILITY

The Visitors Center and the Galleries are equipped with both a security system and a fire suppression system. However, Anne Arundel County, Quiet Waters Park administration and staff, and The Friends of Quiet Waters Park, individually or collectively, will not be responsible for loss or damage to artwork due to theft, accident, fire or other causes.
