

## Call for Art -- ALL Members -- A Juried Exhibit!

The Society has been accepted by Maryland Hall for Creative Arts to exhibit in the Chaney Gallery from May 27 - July 3, 2014.

This juried exhibition is open to all active members, accredited and general.  
**Juror:** Kerry Dunn, *Best of Show, 2013 International Portrait Competition, Portrait Society of America*

### Title:

A Moment Expressed - The Figure and Portrait

### Nature of Work:

The Society asks artists to envision their subjects in a moment in time described by an emotion or in an environment, whether outdoor in the landscape or in an interior setting. Art will be of the figure and portrait, but not of a traditional pose (head and shoulders, etc). Figurative work will be draped or partially draped and will exclude completely nude frontal poses, but may depict the back view. MHCA is a community-based art center.

### Submission Guidelines

Members may submit up to 3 original works completed within the last 3 years including drawings, paintings, sculpture and prints using traditional mediums.

### Entries

Artists may submit three (3) works for consideration by March 19, 2014

1. 2-D works may not be larger than 60" in any direction. Include outside edges of frame. *Work must be framed* and ready to hang with wire and sturdy enough for normal handling. Wet canvases, wet frames and entries mounted behind glass without frames will not be accepted. 3-D works must fit 15" square pedestal. Artist's name, title and contact information must attached to back of work.
2. **All work must be priced for sale; no POR.** Works previously exhibited in an MSPP show are not eligible.

### Submission Format

2. Submit one JPEG image per work entered. File should be between 3-4 megs with the longest dimension 2500 pixels.

3. Label files as:

Last Name - First Initial - Title - Size - Price.jpeg

Example: *degas.e\_dancer20x30\$500.jpeg*

4. Include in the body of your email:

a. Your full name, mailing address, email address and cell phone (for day of delivery)

b. Identify each piece on *separate lines*:

Name, Title, Size, Medium, Price

**Please exclude the words, Name, Title, Size, Medium, Price.**

### Entry Fees

Fee is \$10 for 1, \$15 for 2 or \$20 for 3 works. Entry fees are nonrefundable. *You must be an active member (2014 dues paid)* in order to submit your work from **January 10 to March 10**. ### Terms for Exhibition

1. Entering this exhibit shall constitute understanding and agreement on the part of the artist with the conditions stated.
2. All work must be professionally presented and ready to be

installed. A 2-D work *must have a frame* with a secure wire or hooks on the back to accommodate the gallery's hanging system. **No clip-on or poster frames. No painted canvas sides. Work not in compliance may be turned away and not allowed into exhibit.**

3. Delivery and pick-up of work is the responsibility of the artist. The artist is responsible for all shipping paperwork, costs, and arrangements. This includes the packing and handling, and delivery for returned works.

4. Measure each work to ensure that it meets size limitations before delivery, include outer edges of frames.

5. Attach label to back with name, title, medium and price. Also include your mailing address, phone and email address.

6. Arrival of work must be on scheduled delivery date.

### Sales

MHCA will retain a 35% commission on all sales with 65% going to the artist. All works **MUST** be available for sale and all sales must go through MHCA. All sold works must remain on exhibit until the end of the show.

### Liability
